### Who are We?

For many not involved in agriculture they may not have heard about CHS, only have a vague idea of Cenex and couldn't even begin to guess what the HS part of CHS once represented.

Our local business has evolved over decades to be part of the largest cooperative in the United States. Locally, our roots go all the way back to the early 1930's with a company called North Pacific Grain Growers. In fact, our barge loading facility in Kennewick, Washington, was originally built by this legacy co-op. Over the years, North Pacific Grain Growers merged with Farmers Union Grain Terminal Association, which became Harvest States Cooperatives, and in 1998 merged with Cenex to form CHS Inc.

Our local business, CHS SunBasin Growers, now operates as part of the Country Operations division of CHS. Representing all retail functions with producers — including grain, agronomy, energy, seed and animal nutrition — this division represent 55 business units, just like CHS SunBasin Growers, across 16 states and 450 communities, providing services to 75,000 producer-owners, including sales of over 300 million gallons of refined fuels, over 2 million tons of fertilizer and \$400 million dollars in crop protection sales, buying in excess of 766 million bushels of grain and selling 1.5 million tons of manufactured feed. This all fits within the larger scope of CHS that annually ships over 9 million tons of fertilizer, sells 3.2 billion gallons of fuel, and trades more than 2 billion bushels of grain.

Our local producers can take pride in ownership of a stable company with the ability to serve not just one need, but many of their needs from grain handling, agronomy, energy and seed. CHS didn't show up yesterday and won't be gone tomorrow. We are here to be your long-term partner and we are proud to serve you and the communities where we work and live.

We continue to evolve and find efficiencies in our operations to competitively serve you. We have new offerings such as MyCHS for online

Producer financing is an important part of planning for the crop season. CHS remains committed to our producers throughout the world, offering short-term and long-term financing programs to fit your needs. Producers can be considered for multiple credit programs with a single application.

The Autumn Rewards program is a great way to take advantage of competitive interest rates for the purchase of specific products, with a Dec. 15, 2021, due date. For a list of qualified products reach out to your sales representative. The program has an interest rate of 2.9%. There will be minimum purchase requirements.

One of our most popular programs — Crop Input Financing Loan program — allows you to purchase our products and take advantage of season-long financing. This aligns your payment due date with your crop income. Current rates are 6.5% AA & A; 8.5% B, variable interest rate with a maturity date of 1/15/2022.

We continue to offer our generic prepayment program. Earn 2.25% APR interest credit, based on remaining prepay balance at the end of each month. Product specific prepays do not qualify.

Here at CHS SunBasin Growers, one of the greatest advantages we have is the size and scope of our cooperative. CHS has locations all over the globe and has relationships with all the major importers of grain throughout the world. These relationships place us, your local team, in a position of knowing what is happening in the export arena that many other local companies do not have access to until it has already happened. Structural changes in the past year have really highlighted this. In addition to that, we are a grower-owned cooperative and pay a portion of our profits back to our growers in the form of patronage. The more successful we are, the more money our growerowners can put in their pockets to grow their operations. We truly are in this together!

#### **Communicate Your Plans for 2021**



### Winter Weather Safety Tips

With the weather turning cold, it's best to recognize the dangers and stages of hypothermia.

- **Mild:** Normal shivering can be the first sign of mild hypothermia, followed by experiencing an overall cold sensation, goosebumps and the inability to perform complex tasks with one's hands. Shivering may become severe, and hands may become numb.
- **Moderate:** Signs include intense shivering, muscle incoordination and labored movements all while remaining alert. As hypothermia progresses to the more dangerous end of the moderate spectrum, the person may have difficulty speaking and amnesia may start. In addition, the victim may be unable to use his or her hands and may experience violent shivering and stumbling.
- Severe: When severe hypothermia sets in, shivering will stop, exposed skin may turn blue and puffy, and the victim may lose the ability to walk. He or she may become severely confused and lack awareness. If hypothermia progresses further, muscles will become rigid and pulse and respiration rate may decrease. In its final stages, severe hypothermia may result in pulmonary edema, cardiac and respiratory failure, or death.

When working during this time of year, remember to stay aware, stay warm and stay safe.

#### **Contract Fuel for Peace of Mind**

With the way fuel prices have fallen and the lows we have seen, this is the time to think about next season's diesel fuel contracts. At CHS SunBasin Growers, we see contracts as a type of insurance. Sometimes there is really no savings by contracting but it ensures you have fuel locked in at a price that works for you even if the markets are volatile or after a natural disaster. We also advise to contract at most only 50 percent of your needs just in case the markets go down and to protect yourself if the weather or other issues keep you from taking the gallons within the contracted time frame.

The contracts we recommend the most are storage contracts and multi-month contracts.

- **Storage contracts**. You contract a set amount of gallons, paying \$.035 per month per gallon on the gallons still in storage. All gallons required to be taken by Oct. 31.
- **Multi-Month contract.** Select 3 consecutive months and the number of gallons you want. At any time within that 3-month period you can take the gallons, but all gallons are required to be taken in during the 90-day period.

Also attractive about contracting is nothing will be invoiced until the gallons are delivered.



This chart shows what price trends have been for the last couple of years. Prices are normally lower in the winter than the summer but there is still the chance it could go lower as it did this last year.
